The Minor Prophets: Amos and Obadiah

Dear Brothers and Sisters in Christ,

During 2025, we will be journeying together through the minor prophets. Last month I forgot to include one, so you get to read two this month. Don't worry; one is only 21 verses!

Amos

This month I invite you to read the book of Amos. You might be familiar with Amos from Martin Luther King, Jr.'s “I Have a Dream” speech in which he quotes the prophet: “Let justice roll down like waters, and righteousness like an ever-flowing stream” (Amos 5:24).

God, through Amos his prophet, has no patience for false worship – in particular: worshipers who say one thing but then do another, particularly when it comes to oppressing the poor.

Amos has words of judgment both for the nations surrounding Israel, and for Israel itself. We should take that to heart: God judges all nations according to *his* standard for justice and righteousness.

We often conclude worship with ancient dismissal: “Go in peace. Remember the poor.” I cannot think of a better summary of the book of Amos.

Obadiah

This month I also invite you to read the book of Obadiah.

It's the shortest book in the Old Testament, only 21 verses! It tells the story of the tension between the nation of Israel and the nation of Edom. The relationship between these two groups of people goes all the way back to the story of the Israel (Jacob) and Esau, sons of Isaac and Rebekah and grandsons of Abraham and Sarah. Israel became the people of Israel and the descendants of Esau became the nation of Edom.

If there was tension in this family, between Israel and Edom, it got ramped up in a terrible way when the Babylonian Empire conquered Israel and defeated Jerusalem. The Edomites not only stood by and watched it happen, they even participated in hurting their brothers and sisters, including Israelite refugees. But their pride and self-exaltation became their downfall. Verses 1-14 in Obadiah are directed at them.

But then Obadiah takes a turn. In verses 15-18, God's judgment directed at prideful Edom is expanded to include all nations who are full of pride and exalt themselves. Not one nation is exempt. Pride goes before the fall, as the saying goes. All prideful nations will be judged.

But Obadiah does not end with judgment. God promises to keep a remnant and, through that remnant, to restore a New Jerusalem (Mount Zion) according to his ways. The short book of Obadiah reminds us that God will deal with evil and bring his kingdom of peace.

Helping Jesus

Watch and pray so that you will not fall into temptation.

The spirit is willing, but the flesh is weak.

Matthew 26:41

Most of us can remember “helping” our parents when we were children. For me, helping usually consisted of my holding a tool while my father worked nearby. Sometimes I’d get to turn a wrench or finish pounding a nail, but my father could easily have done those tasks without me. Eventually I realized that this time spent helping my father was an opportunity for me to learn and practice skills that I would one day teach my children.

I think that Jesus was doing the same thing with his disciples in Gethsemane. “Watch and pray so you will not fall into temptation,” Jesus says to them after they’ve fallen asleep. Jesus is not asking them to do this for his own benefit but for theirs.

Just as my father used my help to teach me the things I would need to know as I grew into adulthood, God invites us to participate in serving the world. Whether through prayer and worship, caring for the poor, looking out for those who are alone, or providing for those without housing, God uses these opportunities to shape us into mature disciples.

God includes us not because the job can’t be done without our help but because God has chosen to involve all of us in the work of the kingdom.

Every circumstance is an opportunity to learn how to serve God.

Church Finances

For February 2025, we had a beginning balance of \$6,828.48, receipts of \$23,241.46 and saving accounts withdrawals of \$4,000.00 from capital improvements and \$1,594.55 from building/maintenance for a total income of \$28,836.01, expenses of \$35,561.23 and an ending balance of \$103.26.

In February, we incurred a large expense of \$12,603.12 for several HVAC system items. This was the reason we had to make savings withdrawals of \$4,000.00 from capital improvements and \$1,594.55 from building/maintenance. In the last 14 months, we have had to spend over \$40,000.00 for HVAC issues. It is our thought that we should have our HVAC systems at proper operating levels now. We still have an annual HVAC contract renewal in the Fall of 2025 in the \$5,000.00 neighborhood.

Also in February, we had an annual Boiler System Backflow Test performed. Unfortunately, our backflow protection failed. Repairs will cost \$1,757.00 which includes materials for the check valve rebuild kit and labor provided by a licensed certified repair person. This work needs to be completed as soon as possible.



Monday, March 10, 2025 at Church

Attendance: Cindy Bench, Mark Cuthbertson, Gary Diefenthaler, Al Gahler, Jody Kapp, Jon Overmyer, Kim Reif, Karen Schanke, Pastor Matt Musteric.

The meeting opened with devotion on the First Article of the Apostles' Creed & Prayer by Pastor Matt. Gary made a motion seconded by Jody to approve minutes from the February 10 council meeting. MC. Mark made a motion seconded by Cindy to approve February Treasurer's Report. MC.

Pastor's Report: Pre-school program on February 23 went well; **March & April:** Lent Wednesdays Round Robin; **March 23:** Ryder Nino Baptism; **April 13:** Palm Sunday; **Maundy Thursday:** April 17 at St. Luke's; **Good Friday:** April 18 at St. Peter; **Easter:** April 20; **Alice Bowersox** Funeral: February 14; Transfer: **Mark Starkey** to St. Peter, Norwalk per his request on February 25; February Pastoral Care & Visits total was 24; Continuing Education dates were listed; **Sabbatical application** for 2026 will be resubmitted by March 12 deadline.

Education: Gary reported that they are reviewing **Sunday School material** for next year; Gary made a motion seconded by Mark to have **Family Time Gathering** at 11am on April 13. MC.

Finance: Mark reported that they discussed routine monthly matters; tabled Accountable Reimbursement Policy discussion; discussed the overwhelming **HVAC costs**; possible **Memorial Project:** enhanced altar area lighting; discussed copier costs, office security issues, and custodial supplies. Mark made a motion seconded by Cindy that Maundy Thursday and Good Friday offerings go to wherever St. Luke's designates for Maundy Thursday. MC.

Property: Al reported that John, Wade, Al, and Joe handled **snow removal** from parking lot and sidewalks during winter; Randy contacted Northwood Door for repair to **main entrance door** and will look into repair to kitchen exterior door; **Boiler system** in basement failed backflow test and requires rebuild kit for check valve and must be repaired or could be shut off by state. Cindy made a motion seconded by Gary to repair the check valve backflow system at cost of quoted price of \$1757. MC.

Outreach: Cindy reported that will be collecting green foods for **blue barrel** in March which will go to Elliston Food Pantry; continue to encourage signing up for **worship assistants**; **Picture Board** is up and encourage sharing of photos of church events; **Caring Shepherds** have not met but discussed communion training; Rufena needs **greeting cards**; plan on holding seminar in May or June concerning **End of Life Legalities**; offering **weekly outreach opportunities** in the bulletin; March 28: **packing lunches** and distributing them in Junction area on March 29; collecting **toilet paper** for ERCU during Lent; will be **cooking and serving** at Salem on April 18; working on **Instant Church Directory**.

Worship: Jody reported that they have not met.

Old Business: discussed the alarm system codes which are being worked on.

New Business: The committee (Mark Cuthbertson, Kim Reif, Karen Schanke, and Pastor Matt) interviewed three candidates for **Office Administrator position** and recommended hiring Yvette Simpson. Jody made a motion seconded by Gary that Yvette be offered the job starting April 7 and both she and Shirley be paid same salary during training. MC. Al made a motion seconded by Kim that Office Administrator will have no vacation or sick pay leave until January 2026. MC. Kim made a motion seconded by Jody that incoming cash each Sunday be deposited as cash rather than a check. MC
